# Legislative Report

Mr. Wheeler reported that the State School Board approved a measure to challenge the Federal Government on it's right to align funding with how schools handle gender identity issues. Ohio now joins several other states challenging the Federal Government on this issue.

Additionally, a bill is currently in the legislative process that could potentially change the current practice of keeping a student from advancing to the next grade if the student does not pass the Third Grade Reading Guarantee.

Mr. Bailey reported that Bill 733, Accelerated Appalachia School Building Assistance Program, has been proposed and is similar to a bill that was passed in 2000 known as the Accelerated Urban School Building Assistance Program

### **Tri-County Career Center Report**

Mr. Dicken reported that 113 pupils had perfect attendance the first 9 weeks. There was a 67% increase in food sales with the new food company. The Board Members received letters from some of the students requesting teachers be allowed to carry firearms; the Board did not act on the request. A new Driver's Education Instructor has been hired. The money received from the state through Foundation funding will basically stay the same this year as compared to last, but the Career Center will likely get more funding for specific functions. Finally, Governor Mike DeWine visited Tri-County Career Center.
