Legislative Report

Ms. Dugan reported that the House of Representatives at the federal level is pushing an American Teacher Act which will set the minimum teacher salary to \$60,000 per year. Ohio SB1, which includes the Fair School Funding Formula, is being questioned for using data from 2018 to determine current school funding. Finally, many area schools have had a Title IX complaint filed against them for reasons surrounding the equality of athletics for boys and girls.

Tri-County Career Center Report

Tri-County Career Center currently has 22 programs. 91.2% of the students on 9

a career-tech path are employed following graduation. The financial audit results were reviewed. Connie Altier, Superintendent, is a member of a group working to divide millions of dollars earmarked for Career Tech schools.
