**22-145.** Mr. Wood moved to approve the following Superintendent's Reports and Recommendations as presented by Heather Wolfe, Superintendent:

- A. Approve the updates to the Substitute Teacher and Substitute Aide Lists for Athens, Meigs and Perry Counties.
- B. Amend the Two Year Contract (2022 through 2024) to Brittany Stammler, Paraprofessional at Beacon School, to full time with Board approved benefits, effective November 1, 2022.
